PROCEDURE FOR IMPORTING RAW MATERIALS (YELLOW MAIZE, SOYA BEANS, SOYA BEAN MEAL, COTTON SEED CAKE, SUNFLOWER CAKE, WHITE SORGHUM, FISH MEAL, DRIED DISTILLERS GRAINS WITH SOLUBLE (DDGS) AND RAPESEED CAKE) FOR USE IN THE MANUFACTURE OF ANIMAL AND CHICKEN FEED, WITH 99.1% NON-GM CONTENT

Preamble

Following the publication of Gazette Notice No. 6615 dated 10th June 2022 on the exemption from import duty on imported raw material used in the manufacture of animal and chicken feed, the National Biosafety Authority (NBA) hereby provides guidance on the procedure to be followed on the importation of these raw materials;

Procedure for the importation

1. Before importation, the importer is required to obtain from the supplier a GMO Certificate of Analysis (based on the PCR test) of the consignment. The certificate should be from an accredited laboratory such as SGS.
2. The Importer then fills an application form titled "**Application Form for Importation of Duty-Free Non GMO Animal Feed Raw Materials into Kenya** (available at www.biosafetykenya.go.ke) and sends it to the National Biosafety Authority (NBA) (attaching the certificate of analysis).
3. The importer is required to make a payment of Kshs. 2,000 as processing fee to NBA.
4. The Authority reviews the application and the certificate of analysis and makes a decision within 7 days.
5. The importer then proceeds to other relevant agencies for clearance and issuance of import permit.

6. The Authority's Biosafety Inspectors are at liberty to take samples at the port of entry for confirmatory testing at the cost of the applicant.
7. The Importer shall ensure that ALL imported grains are milled into flour or animal feed to avoid their possible propagation in the local environment.

The outlined procedure is only applicable during the period of emergency importation ending on 31st October 2022.
